

MINUTES OF THE ORGANIZATIONAL MEETING OF THE CITY COUNCIL OF EUFAULA, ALABAMA HELD ON THE 2ND DAY OF NOVEMBER 2020, AT 5:15 P.M.

The City Council of the City of Eufaula met in an organizational session on November 2, 2020, at 5:15 P. M. in the municipal courtroom at the Eufaula Police Department Complex.

Joy White, City Clerk/Treasurer, called the meeting to order and stated that this was an organizational meeting of the newly-elected mayor and city council.

Pastor Alan Cassady gave the invocation, followed by the Pledge of Allegiance.

Upon call of the roll the following members-elect were present: Ben Garrison, Otis Hill, Marvin Brown, John Robinson, and Wes Register. Absent: None.

The Honorable Walter Calton, Municipal Judge, administered the oath of office to Mayor Jack B. Tibbs, Jr., and council members Ben Garrison, Otis Hill, Marvin Brown, John Robinson, and Wes Register.

Mrs. Joy White, City Clerk/Treasurer opened the floor for nominations for City Council president. Mr. Robinson nominated Wes Register for council president. Mr. Brown nominated Ben Garrison for council president. Mrs. White called for any other nominations. There were no other nominations. Mrs. White then called for a roll call vote for Wes Register for council president. The following vote was recorded in favor of Wes Register. Yea: Mr. Brown, Mr. Robinson, and Mr. Register. Nays: Mr. Garrison and Mr. Hill. Mrs. White announced that Mr. Wes Register was duly elected City Council president.

Mrs. White then turned the gavel over to Council President Register, who opened the floor for nominations for City Council president pro tem. Mr. Brown nominated Mr. Hill. Council President Register called for other nominations. There were no other nominations. There being no further nominations, Council President Register called for a roll call vote for Mr. Hill as City Council president pro tem. The following vote was recorded in favor of Mr. Hill: Yea: Mr. Register, Mr. Robinson, Mr. Brown, Mr. Hill, and Mr. Garrison. Nay: None. Council President Register announced that Mr. Otis Hill was duly elected City Council president pro tem.

Council President Register assigned council members to the following committees:

- Ben Garrison - Finance
- Wes Register - Education, Library, Zoning, and Chamber of Commerce
- John Robinson - Parks, Recreation & Airport
- Marvin Brown - Streets, Sanitation & Cemetery

Otis Hill - Police, Fire and Personnel

Council President Register introduced the ratification of the banking policy and called for a motion to adopt. Mr. Hill moved to ratify the city's banking policy. The motion was seconded by Mr. Robinson. After a voice vote, City Council President Register announced the motion had carried.

There being no further business to come before the council, the same was on motion by Mr. Robinson and seconded by Mr. Hill, adjourned this 2nd day of November, 2020.
